*This booklet is your “**Official Notice of Change of Appraisal**” for any and all properties you own in the Town of Montgomery, Vermont.*

The Montgomery Board of Listers and Lewis Appraisal Services have completed a full reappraisal of all real property in the Town of Montgomery as of April 1<sup>st</sup>, 2014. As of today, the **Preliminary Grand List** has been lodged with the Town Clerk and is available for inspection during normal business hours. Please keep in mind that this booklet contains the majority of the information you will find in the Preliminary Grand List and any in-depth questions should be reserved for and directed to the Board of Listers.

We will be happy to provide a copy of your **Cost Report** for review should you have any questions or concerns about your appraised value. We will have extended Listers Office hours until **Wednesday, June 25<sup>th</sup>**, our **Pre-Grievance Informational Meeting** period, to review your Cost Reports and questions. This is also the appropriate time to seek assistance in gathering information if you believe you would like to proceed to a **Grievance Hearing**. We welcome the opportunity to address your concerns.

In accordance with **Title 32 V.S.A. § 4111(e)**, notice is hereby given that the undersigned Board of Listers within and for the Town of Montgomery, County of Franklin, State of Vermont, will meet at the Montgomery Town Office to hear grievances of persons, co-partnerships, associations, or corporations aggrieved by any of their appraisals or by any of their acts as Listers.

**Title 32, V.S.A. § 4111(g)** reads, in part, as follows: “A person who feels aggrieved by the action of the Listers and desires to be heard by them, shall, on or before the day of the grievance meeting, file with them their objections in writing and may appear at such grievance meeting in person or by his agents or attorneys. Upon the hearing of such grievance the parties thereto may submit such documentary or sworn evidence as shall be pertinent thereto.”

Should you wish to grieve your assessment you will find our **Application for Grievance** online at **montgomeryvt.us/listers.htm**. If you do not have internet access, or would prefer, you may obtain an Application at the Town Office or by calling (802) 326-4719. If you are unable to obtain an Application as stated, you may submit a **signed, written grievance letter**. Either form may be returned to the Montgomery Town Office or mailed to:

**It will greatly assist you in your Grievance process to prepare the following information, and submit it with your Application or written grievance letter, as evidence:**

- 1) **Three properties, that have sold, you believe to be similar to your own.**  
*\*Comparison property sales may be from neighboring towns*
- 2) **List the items, if any, you feel adversely affect your property value.**
- 3) **Your opinion of the Fair Market Value of your property.**

**All Applications for Grievance must be received by 4:00pm. Wednesday , June 25<sup>th</sup>.**

*\*If your Application is received after the close of Grievance Hearings,  
we will be unable to hear your grievance until next year.*

## ~~~ Glossary of Terms ~~~

- Appraised Value:** The value achieved by entering all of the defining characteristics of a property into the valuation software (CAMA). This value should reasonably represent the Fair Market Value (FMV) of your property.
- CLA:** (a.k.a. Common Level of Appraisal) A percentage that represents the disparity between property assessments and what they have sold for.
- Cost Report:** (a.k.a. Lister Card) A printed report of all distinguishing characteristics of your property and the calculations used to determine your assessed value.
- Current Use:** A program offered through the State of Vermont that provides a level of exemption for larger parcels of undeveloped or farm lands. The Current Use Advisory Board sets the use values for farm and forest land annually. *If you are interested in this program please call your Board of Listers for information.*
- FMV:** (a.k.a. Fair Market Value) The fair and reasonable amount you could expect to sell your property for.
- Grand List:** The final and complete listing of all taxable parcels within the Town. This listing includes Property Owners names, mailing addresses, Tap Map numbers, appraised values, Homestead Values and any Current Use or Veterans Exemptions. The **Preliminary Grand List** contains all of the same information BEFORE Grievance Hearings.
- Grievance:** Formal hearings to appeal the appraised value of your property with the Board of Listers.
- Homestead:** A homestead is a dwelling, accessory buildings (not used for business or rental purposes), and land surrounding said dwelling. **For tax purposes**, this property must be owned and occupied as the property owner's primary residence in order to qualify for the Residential Education Tax Rate.
- Housesite:** The value of a dwelling and up to 2 surrounding acres as well as any accessory buildings located on said acreage that are not used for business or rental purposes.
- Veterans Exemption:** Veterans who qualify for an exemption receive a \$40,000 reduction in their assessed value. This **is not** reflected in the values in this booklet. *If you feel you may qualify, please contact the VA for the appropriate application.*

## ~~~ Additional Information ~~~

- 1) Property owners enrolled in the Current Use program will receive their 2014 Use Value allocation via a separate mailing.
- 2) Please notify the Town Offices of any change of address or property changes (i.e. new structures, additions, alterations, and removals). **Please remember**, Building Permits are required prior to new construction and/or additions. Questions can be answered by the **Zoning Administrator**. Refer to the Town website for contact information or call the Town Office for more information.
- 3) Tax Maps are available for viewing at the Town Office. These maps are updated periodically as necessary to reflect new surveys and transfer of ownership. If you have had a certified survey, it is important to file a copy with the Town Clerk to maintain accurate property records.

## ~~~ Reappraisal FAQ's ~~~

Below are a few examples of frequently asked questions (FAQs) that we expect to answer for property owners after receiving their reappraisal values.

### **1) Why did the Town decide to do a reappraisal?**

The Town was required to complete a reappraisal by the State of Vermont. Property sales in Montgomery were no longer close to their assessed values, resulting in a Common Level of Appraisal (CLA) that the State deemed unacceptable. The CLA is an average percentage of the differences between property assessments and what those properties actually sell for. Any CLA under 80% will trigger a reappraisal. Our CLA was 75.88% in 2011, 76.13% in 2012, 77.57% in 2013, and 77.03% in 2014. In short, properties in Montgomery are selling for significantly more than their assessed Grand List values.

### **2) What is the purpose of reappraisal?**

All properties are required to be assessed at Fair Market Value (FMV), which is defined as what you would reasonably be able to sell your property for. By thoroughly inspecting properties, uniformly applying the same criteria town-wide, and taking into consideration all contributing factors, your assessment should now be at 100% of FMV.

### **3) How did you determine my property value?**

We updated the programming of our CAMA software to correctly reflect the current market. Updates were made to the Land Schedules, Cost Tables and Depreciation Charts. Following the site visit to your property, the data collected (i.e. square footage, design, finish, wear, etc.) was entered into CAMA. In addition to inspection of individual properties, we analyzed sales for Montgomery and surrounding towns for the past three years.

### **4) I have not made any improvements to my property. How can the value change?**

The values of properties were last set during our 2004 Reappraisal and have only been adjusted as the result of permitted improvements or grievance. The market has changed greatly over the last 10 years, resulting in potentially increased values. Between 2004 and 2008 alone, market values were still climbing at a rate of 5% per year. In contrast, most properties have had additional depreciation that can only be assessed during a complete reappraisal.

### **5) Why did my property values change more or less than other properties?**

While the most obvious reason for change in value would be due to improvements or depreciation of a property, there are many factors that affect value. It is common for one area of town to have higher values than another area due to location and neighborhood characteristics. It is also common that some properties were not as well maintained as others, which is not always easily determined without inspection. Another area of impact for many properties has been that their previous assessments were based on inaccurate measurements. As a result, it is not reasonable to compare properties simply on their percentage of change.

### **6) My property assessment changed substantially. Does this mean my taxes will increase/decrease by the same amount?**

No. Even if your assessment has doubled it does not mean that your tax liability will double. As a result of the 2004 Reappraisal, when 94.3% saw their assessment increase, roughly 45% of Montgomery taxpayers saw their Tax Bill go down. Remember that the total Grand List has changed as well. The budget passed at Town Meeting and the amount of taxes to be raised is set. The Municipal Tax Rate will be adjusted as a result of the reappraisal. The Education Tax Rate set by the State in July will no longer have to be adjusted for a low CLA, which has resulted in a higher tax rate in previous years.
