CONSERVATION COMMISSION MEETING (unapproved draft)

- Additions/Deletions to Agenda – None
- Minutes from September 5, 2018 – Todd made a motion, seconded by Misty, to accept the minutes. Passed unanimously.
- Treasurer’s Report/Fundraising/Expenses Update: There was no Treasurer’s Report at this meeting. Expense: Charlie made a motion, seconded by Todd to pay Kurt Valenta (BugWorks) \$82.50 for the 3<sup>rd</sup> session of Bug Works held at the Montgomery Elementary School in September of 2018.
